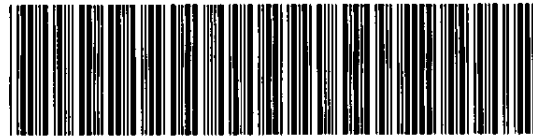

POPPO'S OPERATING AGREEMENT ADDENDUM EXHIBIT 3 (REVISED)

ROLES/RESPONSIBILITIES

Active members, as defined in Article VI in this addendum, are responsible for day to day unit operations in general with specific duties as listed below. Active members are also responsible for training others in their areas of responsibility.

Operations Manager: Rowen Beals, is responsible for overall restaurant operations. This includes scheduling, cash drawer management, inventory controls, ordering supplies and system development. She will work front of house operations per schedule agreed by partners

Kitchen Manager: Patrick Coleman, responsible for recipes, food production, quality control, inventory control, meeting sanitation standards, and maintaining kitchen equipment and supplies in a clean and well maintained environment. He will supervise kitchen operations per schedule agreed by partners.

Service Line Manager: Casey Coleman will establish and maintain food prep and presentation standards, with a focus on customer service, product education and presentation, portion control and sanitation. He will train others in those standards. He will assist the Operations Manager in creating and implementing opening and closing procedures. He is responsible to ensure inventory levels needed to meet volume demands during the day.
