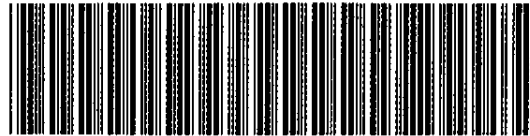

**ARTICLE I
NAME**

The power to alter, amend or repeal these regulations shall be vested in all the members of the company.

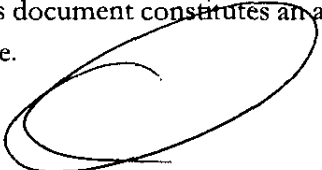
ARTICLE VI PROPERTY
