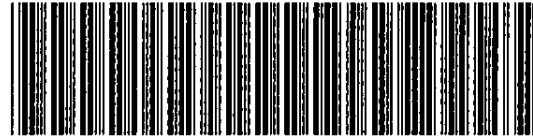

The name of the Limited Liability Company shall be BIG BLUE PROPERTIES, LLC

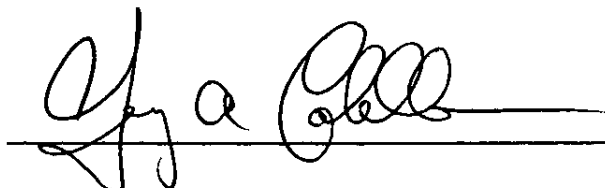
