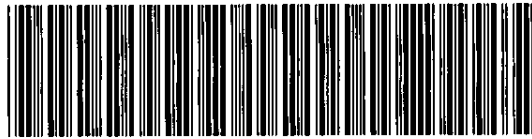

The name of the Limited Liability Company is READY ROCKLEDGE, LLC (the "Company").


**ARTICLE II - Address**

**ARTICLE III - Registered Agent and Office**


