NAME**

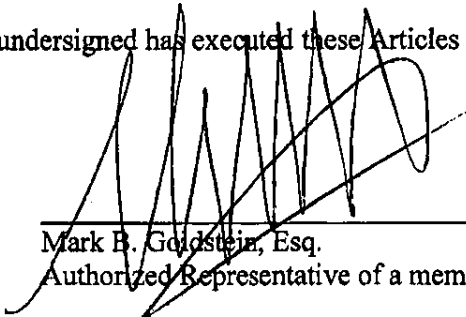

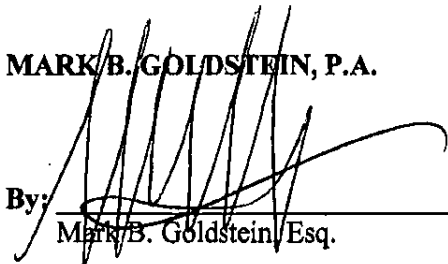
