ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a multi-member limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I
NAME AND ADDRESS

The name of the limited liability company shall be UNITED AMERICAN RECYCLING SERVICES, LLC ("Company"). The principal place of business of the Company in Florida shall be 460 NW 52nd Avenue, Ocala, Florida 34482 and the mailing address of the Company shall be P.O. Box 5058, Ocala, Florida 34478.

ARTICLE II
DURATION
