**ARTICLE 1
NAME**

The name of this Limited Liability Company is: COA HOME CARE, LLC

**ARTICLE 2
PRINCIPAL OFFICE AND REGISTERED AGENT**

No part of the net earnings of the Company shall inure to the benefit of, or be distributable to, its trustees, officers or other private persons except that the Company shall be authorized and empowered to pay reasonable compensation for services rendered.

Upon the dissolution of the Company the Managers shall, after paying or making provisions for the payment of all of the liabilities of the Company, dispose of all of the assets of the Company to Council on Aging of Volusia County, Inc., or to such organization or organizations organized and operated exclusively for charitable or educational purposes as shall at the time qualify as an exempt




