ARTICLES OF ORGANIZATION

FOR

I-10/19 CHEVRON, LLC A FLORIDA LIMITED LIABILITY COMPANY

ARTICLE I Name:

The name of the Limited Liability Company is: I-10/19 CHEVRON, LLC.

ARTICLE II Address:
