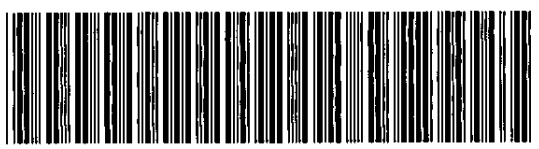

Name and Principal Place of Business


