  - (k) Cease its activities and surrender this Certificate of Organization.
- Have and exercise all powers necessary or convenient to effect any or all of the (I) purposes for which the limited liability company is organized.
- Transact any lawful business which the Members or the managers find to be in aid (m) of governmental policy.
- Pay pensions and establish pension plans, profit-sharing plans and other incentive (n) plans for any or all of its managers and employees.
- Be a promoter, incorporator, general partner, limited partner, Member, associate, (0)or manager of any corporation, partnership, limited partnership, limited liability company, joint venture, trust, or other enterprise.

**(p)** Have and exercise all other powers necessary or convenient to effect its purposes.
