

#### **ARTICLES OF ORGANIZATION**

#### <u>OF</u>

### CUNILL POLA, LLC

I, THE UNDERSIGNED, subscriber member of the Articles of Organization, on behalf of the members, for the purpose of forming a Limited Liability Company under the Laws of the State of Florida, pursuant to the Florida Limited Liability Company Act, state:

#### ARTICLE ONE

The name of this company shall be: Cunill Pola, LLC.

## ARTICLE TWO

The Managing Member(s) with the consent of the majority of the ownership is authorized to make an Operational Agreement to govern the Company and to amend same from time to time.

#### ARTICLE EIGHT

A member may not transfer its interest without written consent of a majority of the remaining members except as otherwise provided in the initial subscription. In the event of an Assignment or if a member ceases to have an interest in the Company, the Company shall still continue.
