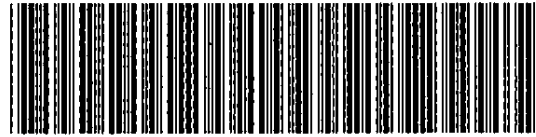

**ARTICLES OF ORGANIZATION**




ARTICLE VI : INDEMNIFICATION
