**ARTICLES OF ORGANIZATION
OF
ENTERPRISES KIRK, LLC**

The undersigned, being a duly authorized representative of a member, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I

The name of the limited liability company is **ENTERPRISES KIRK, LLC**, a Florida limited liability company, (the "Company").

**ARTICLE II
ADDRESS**

The principal office and mailing address of the Company is: 40 S.W. 13th Street, Unit 802, Miami Florida 33130

**ARTICLE III

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.


**ARTICLE VII


