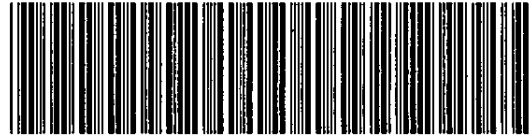



Manager –Managed Company


The Limited Liability Company is to be managed by one or more managers and is therefore, a manager managed company.
