NAME**

The name of this Limited Liability Company is LGI1, LLC.

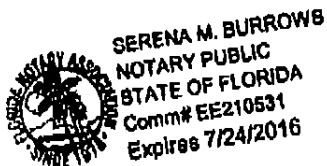


