**ARTICLE I - NAME**

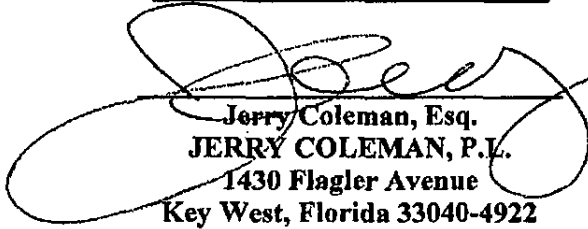

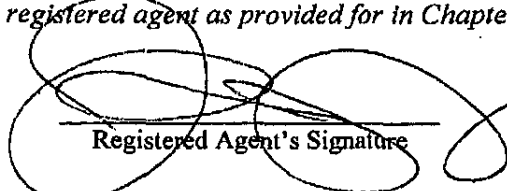

**ARTICLE V – MEMBERS’ RIGHTS TO CONTINUE BUSINESS**

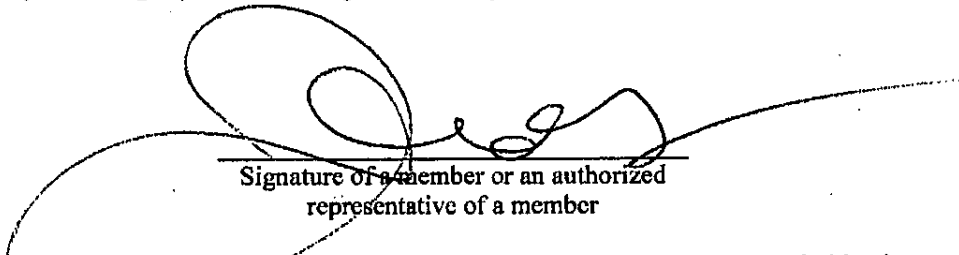
