**Articles of Organization
of**

(A Florida limited liability company)

1. The name of this limited liability company is Everlasting GP LLC (the "Company").


6. The Company will be managed by one or more managers appointed by its members. The name and address of the initial managers who will continue to serve until replaced by the members is set forth below as follows:


