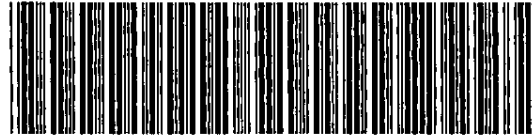

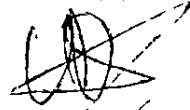

**ARTICLES OF AMENDMENT TO
THE ARTICLES OF ORGANIZATION
OF PANDORA PEMBROKE GARDENS, LLC**

Pursuant to the provisions of Section 608.411 of the Florida Statutes, the undersigned Florida company hereby adopts the following Articles of Amendment to its Articles of Organization:

Article I - Name and Date of Filing

The name of the company is PANDORA PEMBROKE GARDENS, LLC (hereinafter referred to as the "Company"). The Articles of Organization of Company were originally filed on March 18, 2013. The Company's Florida document number is L13000035481.

Article II - Adoption and Text of Amendments

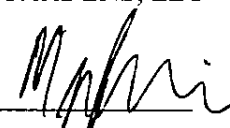
