Pursuant to the provisions of Section 608.411, Florida Statutes, PIRATE PROMOTIONS, LLC, a Florida limited liability company (the "Company"), adopts the following Articles of Amendment to its Articles of Organization:

ARTICLE I
Name

The name of the Company is PIRATE PROMOTIONS, LLC. The Articles of Organization of the Company were filed with the Florida Secretary of State on May 28, 2013.

ARTICLE II
Amendment

Article III of the Articles of Organization of this Company is hereby amended for the purposes of changing the initial managing members of the Company by deleting the existing Article III in its entirety, and substituting the following therefore to wit:
