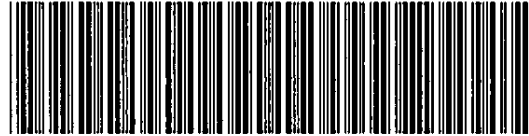

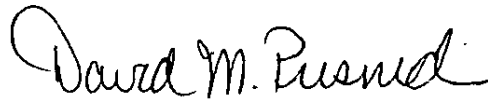

ARTICLE I - NAME

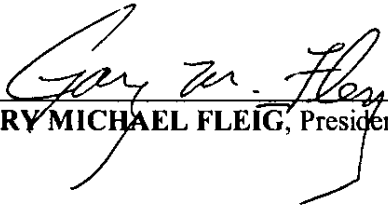

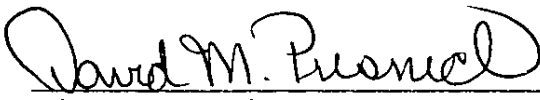
