The Managers and the members shall not be personally liable for the debts, obligations or liabilities of the Company.

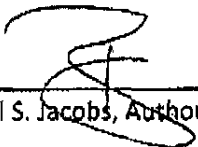
ARTICLE VII

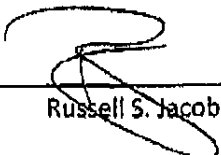
