#### PLAN AND AGREEMENT OF MERGER

THIS PLAN AND AGREEMENT OF MERGER (the "Plan and Agreement") is hereby adopted by and between 5161 Collins 1208, Inc., a Florida corporation (the "Merging Corporation"), and SEA1208, LLC, a Florida limited liability company (the "Entity"), for the purpose of merging the Merging Corporation with and into the Entity (the "Merger").
