The street and mailing address of the principal office of the Company is: 255 Alhambra Circle, Suite 414, Coral Gables, Florida 33134.


ARTICLE III. REGISTERED OFFICE AND REGISTERED AGENT


ARTICLE IV. MANAGEMENT
