ARTICLE I

ARTICLE V



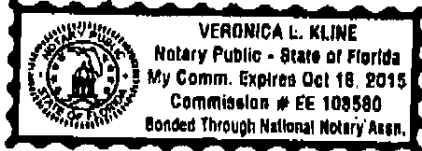


