**SECOND ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF FUNLANDO ADVENTURE TOURS, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

FIRST: The Articles of Organization of Funlando Adventure Tours, LLC, were filed with the Florida Department of State on August 12, 2013, and were assigned Document Number L13000114731. The Articles of Organization were amended on August 27, 2013. This document will amend, restate and supercede the Articles of Organization filed at Document Number L13000114731.

SECOND: The following amendments to the Articles of Organization were adopted by Funlando Adventure Tours, LLC.

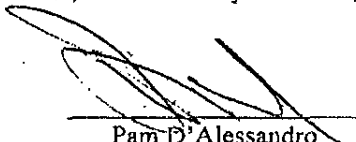
1. Article II is hereby revised to change the name of the Company.
