ARTICLES OF AMENDMENT

TO

ARTICLES OF ORGANIZATION OF NEWCOMB HALL LLC

Article VII of the Articles of Organization of Newcomb hall, LLC (the "Company") is hereby added as follows:

The Company is organized exclusively for exempt purposes under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"). The Company may not carry on activities not permitted to be carried on by an organization described in section 501(c)(3) of the Code. The Company is organized for charitable purposes in accordance with section 501(c)(3) of the Code to facilitate the redevelopment and improvement of areas of blight and deterioration within the municipal limits of the City of Riviera Beach, Florida (the "City"), a municipal corporation duly existing under the laws of the State of Florida and to lessen the burdens imposed on the City and the Riviera Beach Community Redevelopment Agency ("RBCRA"), a public body corporate and local unit of government duly existing under the laws of the State of Florida, in redeveloping and improving such areas of blight and deterioration. The Company is further organized to further the charitable purposes of its members.
