**ARTICLES OF ORGANIZATION
OF
300 BEACH BOULEVARD, LLC**

These Articles of Organization are submitted for the purpose of forming a limited liability company pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, as the same may from time to time be amended, and any successor statute (the "Act").

ARTICLE I - NAME


