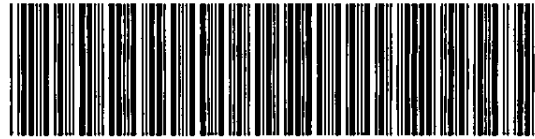

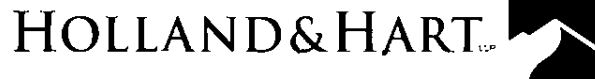

**ARTICLES OF MERGER**  
**OF**

Pursuant to the applicable provisions of the Florida Revised Limited Liability Company Act and the Nevada Revised Statutes, RTWF LLC, a Florida limited liability company ("RTWF FLORIDA"), as the surviving limited liability company in a merger (the "Merger"), of RTWF LLC, a Nevada limited liability company ("RTWF NEVADA"), with and into RTWF FLORIDA, hereby submits the following Articles of Merger:

**Article 1**  
**Plan of Merger**

RTWF FLORIDA and RTWF NEVADA have adopted an Agreement and Plan of Merger (the "Plan of Merger"). The complete signed plan of merger is on file at the registered office of RTWF FLORIDA.

**Article 2**  
**Parties to the Merger**

The parties to the Merger are RTWF FLORIDA and RTWF NEVADA. The address of RTWF FLORIDA's registered and principal office is 705 Tenth Street South, Suite 301, Naples, Florida 34102. The address of RTWF NEVADA's registered and principal office is 705 Tenth Street South, Suite 301, Naples, Florida 34102.

**Article 3**  
**Surviving Company**

The surviving limited liability company is RTWF FLORIDA and is created by the Merger.

**Article 4**  
**Appraisal Rights**

RTWF FLORIDA has agreed to pay to any members with appraisal rights the amount to which such members are entitled under applicable law.

**Article 5**  
**Adoption of Plan of Merger**

The Plan of Merger has been duly authorized and approved by RTWF FLORIDA and RTWF NEVADA in accordance with Section 605.1023 of the Florida Revised Limited Liability Company Act and Section 92A.150 of the Nevada Revised Statutes. The sole member of RTWF FLORIDA and the sole member of RTWF NEVADA have approved the Plan of Merger.

**Article 6**  
**Conversion of Owners' Interests**


Immediately prior to the merger, Jerry W. Severson and JWS, Inc. – II, a Florida corporation, each owned one-half of the membership interests in each of RTWF NEVADA and RTWF FLORIDA. As a result of the merger, each of Jerry W. Severson and JWS, Inc. – II is and shall be and remain a member of and own a one-half membership interest in RTWF FLORIDA and the membership interests of RTWF NEVADA shall be converted into the membership interests of RTWF FLORIDA.

**Effective Date of Merger**


