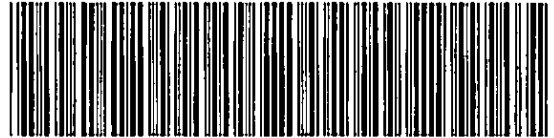

The company has adopted a new name, *Abeka Book, LLC*.


B. Adoption of Amendment
