ARTICLE VI - MANAGEMENT

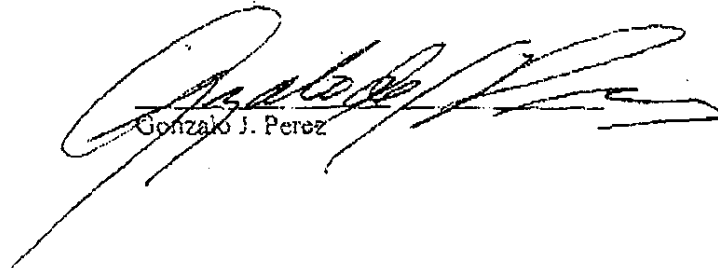

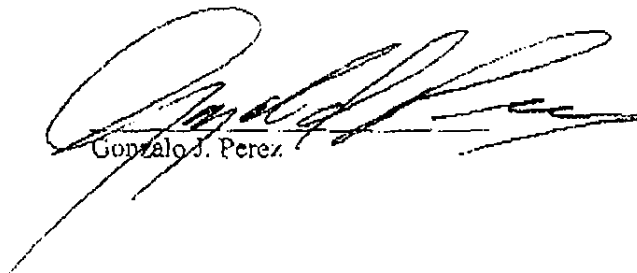
