ARTICLE 9

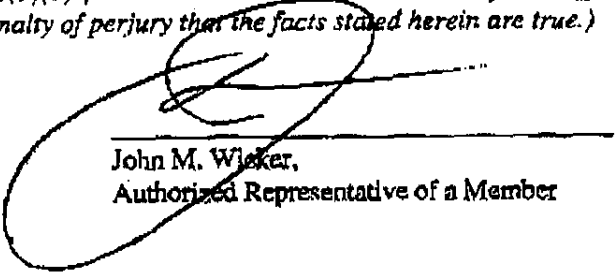

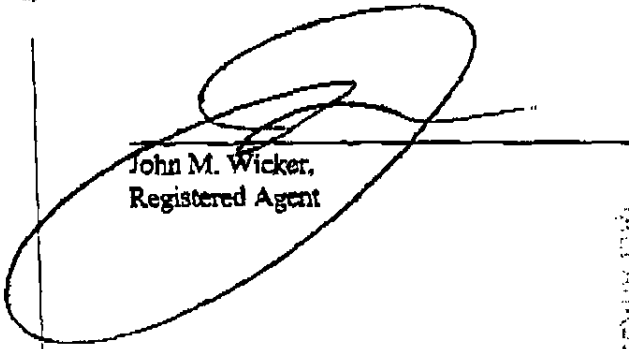
