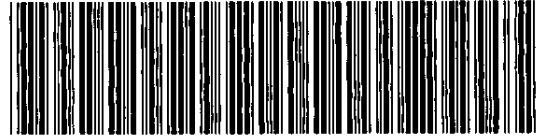

(A Florida Limited Liability Company)

The Articles of Organization for **Community Care of Florida, LLC** were filed on March 14, 2014 and assigned Florida document number L14000044442. Pursuant to the provisions of section 605.0202, Florida Statutes, this Florida Limited Liability Company adopts the following Amended and Restated Articles of Organization:

ARTICLE I — Name

The Company shall indemnify and hold harmless its members and managers against any and all claims and demands pursuant to Fla. Stat. 605.0408.

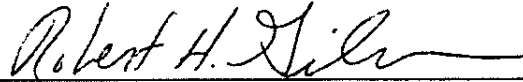
ARTICLE VI – Amendment
