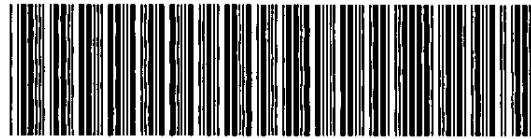

Article IV shall be amended in its entirety to read as follows:


