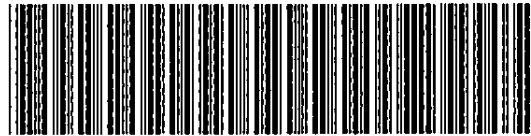

4. The conversion shall become effective upon the filing of the Articles of Conversion with the Florida Department of State.

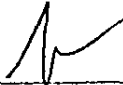

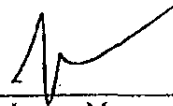

The period of duration for the Company shall be perpetual.

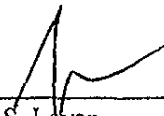

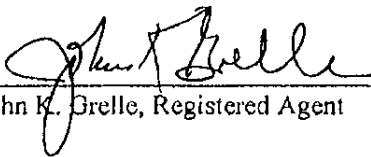
