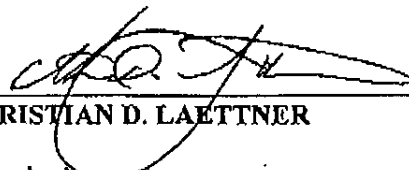
Article VIII
