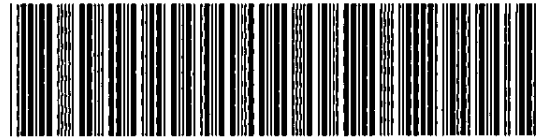

Principal Office




