**ARTICLES OF AMENDMENT  
TO THE ARTICLES OF ORGANIZATION OF

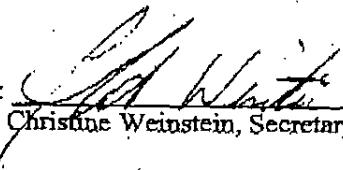
3. The foregoing Articles of Amendment to the Articles of Organization of the Company shall be effective upon filing by the Florida Secretary of State.
