The period of duration of the Company shall be perpetual.

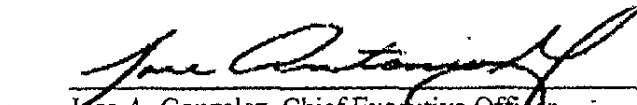
ARTICLE V - INITIAL REGISTERED AGENT
