- 3. Said Corporation was administratively dissolved and I have no intention of reinstating it.

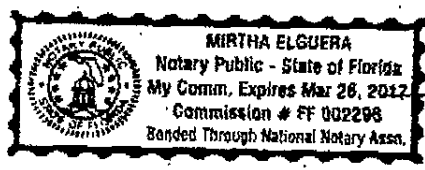
