NEW MEMBERS**



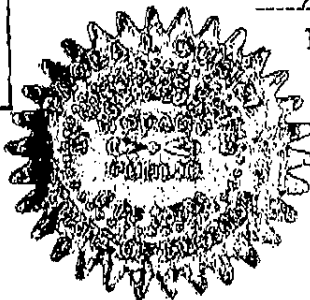
