The undersigned, Frank B. Burge, a natural person competent to contract and a member of Artburg Alliance, LLC, hereby presents these Articles of Organization as the Articles of Organization of Artburg Alliance, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Artburg Alliance, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The mailing and street address of the Company's initial principal office is 155 Crystal Beach Drive, Suite 135, Destin, FL 32541. The Company's principal office may hereafter be at such other place or places as its members from time to time may determine.

ARTICLE III - PURPOSE AND POWERS


ARTICLE VI - MANAGEMENT


