

Unless as otherwise provided by law or expressly assumed, a person who is a manager shall not be liable for the acts, debts or liabilities of the limited liability company.

To the fullest extent permitted by Title XXXVI, Chapter 605, Section 0304 of the Florida Revised Limited Liability Company Act (the "Act"), except as otherwise provided in this Article, the limited liability company shall indemnify any manager or member and may indemnify any employee or agent of the limited liability company who was or is a party or is threatened to be made a party to a threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative, or investigative, and whether formal or informal, other than an action by or in the right of the limited liability company, by reason of the fact that such person is or was a manager, member, employee or agent of the limited company, against expenses, including attorney fees, judgments, penalties, fines and amounts paid in settlement, actually and reasonably incurred by such person in connection with the action, suit or proceeding, if the person acted in good faith, or the care an ordinarily prudent person in a like position would exercise under similar circumstances, and in a manner that such person reasonably believed to be in the best interest of the limited liability company, and with respect to criminal action or proceeding, if such person had no reasonable cause to believe such person's conduct was unlawful. To the extent that a manager, member, employee or agent of the limited liability company has been successful on the merits or otherwise in defense of an action, suit or proceeding or in defense of any claim, issue or other matter in the action, suit or proceeding, such person shall be indemnified against actual and reasonable expenses, including attorney fees, incurred by such person, suit or proceeding brought to enforce the mandatory indemnification provided herein. Any indemnification permitted under this Article, unless ordered by a court, shall be made by the limited liability company only as authorized in the specific case upon a determination that the indemnification is proper under the circumstances because the person to be indemnified has met the applicable standard of conduct and upon an evaluation of the reasonableness of expenses and amounts paid in settlement. Notwithstanding the foregoing, no indemnification shall be provided to any manager, member, employee or agent of the limited liability company for or in connection with the receipt of a financial benefit to which such person was not entitled, voting for or assenting to a distribution to a member in violation of the Act, or a knowing violation of law.
