**ARTICLES OF ORGANIZATION
OF
ATREIDES LLC**

The undersigned, being a duly authorized representative of a member, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I

The name of the limited liability company is **ATREIDES LLC**, a Florida limited liability company, (the "Company").

**ARTICLE II
ADDRESS**

The principal office and mailing address of the Company is: 40 S.W. 13th Street, Suite 802, Miami, Florida 33130.

**ARTICLE III
REGISTERED AGENT AND OFFICE**

The Company designates 40 S.W. 13th Street, Suite 802, Miami, Florida 33130 as the street address of the initial registered office of the Company and names Florida Global Corporate Services LLC as the Company's initial registered agent at that address to accept service of process within this state.

**ARTICLE IV
MANAGEMENT**

The Company shall be conducted, carried on, and managed by a Manager. The initial Manager shall be Eduardo Holguin. The Manager will also have the rights and responsibilities described in the Operating Agreement of the Company. The Manager shall serve in such capacity until a successor is duly elected and qualified.

The period of the Company's duration shall commence with the filing of these Articles of Organization with the Secretary of State, and shall continue perpetually, unless terminated (i) in accordance with the Company's Operating Agreement, or (ii) by the written agreement of a majority of ownership interest.

ARTICLE VI
PURPOSE

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.


ARTICLE VII
