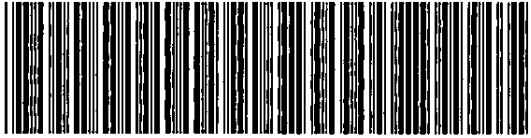

3. The name of the Florida limited liability company as forth in the attached Articles of Organization is Snowball Enterprises, LLC.

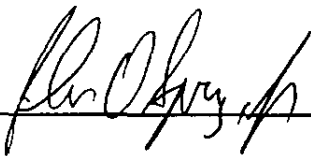
