**ARTICLES OF AMENDMENT TO THE
ARTICLES OF ORGANIZATION
OF

Pursuant to the provisions of Chapter 605 of Florida Statutes, the undersigned limited liability company adopts the following Articles of Amendment to its Articles of Organization.

- 1. Article IV the principal place of business and mailing address is:

“ARTICLE IV

The principal place of business of Adley Homes, LLC shall be 1648 Taylor Road, #153, Port Orange, FL 32128, and the mailing address shall be the same as the principal place of business, or such other place or places as the Members from time to time may determine.”

- 2. Article V is deleted in its entirety and the following is substituted in lieu thereof:
