**AMENDED AND RESTATED ARTICLES OF ORGANIZATION
OF

The undersigned authorized representative of **NORRIS RYBACK GROUP, LLC**, a limited liability company organized and existing under the laws of the State of Florida (the "**Company**"), whose Articles of Organization were originally filed with the Florida Department of State on February 11, 2015, document number L15000026252, adopts the following Amended and Restated Articles of Organization of the Company:

ARTICLE I

Name

The Company's effective date of existence is February 11, 2015, the date the Articles of Organization were originally filed.
