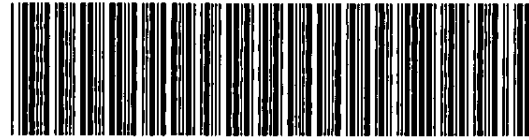

**ARTICLES OF ORGANIZATION OF**  
**504 – 512 NW 3RD AVENUE, LLC**

Articles of Organization for 504 – 512 NW 3rd Avenue, LLC (hereinafter "the LLC") is made, approved, and entered into this 18<sup>th</sup> day of January, 2015, by and between all members of the LLC listed below. The members hereby affirmatively agree to be associated hereto.

These Articles of Organization are consented to by vote and approved by all the members.

**NOW, THEREFORE**, in consideration of the foregoing and the mutual agreements contained herein, and intending to be bound legally, the members agree and contract as follows:

The members organize themselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit.

Further the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

The undersigned, being duly authorized to act as the organizer of this Limited Liability Company pursuant to Chapter 608 and Sections 605.405 and 605.408, Florida Statutes hereby forms a limited liability company under the laws of the State of Florida and adopts the following Articles of Organization for such Limited Liability Company.

**ARTICLE I**  
**NAME AND PRINCIPAL PLACE OF BUSINESS**

The name of the limited liability company shall be 504 - 512 NW 3rd Avenue, LLC, and its principal office shall be located at 811 NW 1<sup>st</sup> Street, in the City of Fort Lauderdale, zip code 33301, County of Broward, State of FLORIDA, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

**ARTICLE II**  
**PURPOSES AND POWERS**

In addition to the powers authorized by the laws of the State of Florida for limited liability companies, the general nature of the business or businesses to be transacted, and which the limited liability company is authorized to transact, according to agreement its Members, shall be as follows:

1. To engage in any activity or business authorized under the Florida Statutes.
2. In general, to carry on any and all incidental business; to have and exercise all the powers conferred by the laws of the State of Florida, and to do any and all things set forth in these Articles to the same extent as a natural person might or could do.
3. To purchase or otherwise acquire, undertake, carry on, improve, or develop, all or any of the business, good will, rights, assets, and liabilities of any person, firm, association, or corporation carrying on any kind of business of a similar nature to that which this limited liability company is authorized to carry on, pursuant to the

provisions of these Articles, Bylaws and/or Operating Agreement; and to hold, utilize, and in any manner dispose of the rights and property so acquired.

ARTICLE III  
EXERCISE OF POWERS

All limited liability company powers shall be exercised by or under the authority of, and the business and affairs of this limited liability company shall be managed as agreed to by the Members of this limited liability company. This Article may be amended from time to time in the regulations of the limited liability company.

ARTICLE IV  
MANAGEMENT

This limited liability company shall be managed as authorized, reserved and as agreed to by the Members:

Each Member of the limited liability company is appointed to manage its affairs, as defined under the Bylaws and/or the Operating Agreement.

ARTICLE V  
MEMBERSHIP RESTRICTIONS

Membership is restricted, reserved, and governed as agreed to by the Members.

ARTICLE VI  
CAPITAL CONTRIBUTIONS

Capital contributions shall be administered, managed, and governed as agreed to by the Members.

ARTICLE VII  
DURATION

This limited liability company existence commences on January 18, 2015, and shall exist until December 31, 2025, or until dissolved in a manner provided by law, or as provided in the Operating Agreement adopted by the members.


