**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION
OF
APAX HOMECARE, LLC**

Apax Homecare, LLC, a Florida Limited Liability Company (the "Company"), whose Articles of Organization were filed on March 18, 2015, hereby certifies as follows:

1. The Articles of Organization of the Organization are hereby amended by deleting the present form of Article I in its entirety and by substituting, in lieu thereof, the following:

ARTICLE I

Name, Mailing Address and Purpose of Organization
