**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION  
OF

1. The Articles of Organization of the Company are hereby amended by deleting the present form of Article III, in its entirety and by substituting, in lieu thereof, the following:

**ARTICLE III**  
**Management and Ownership of the Company**


