The Company's Articles of Organization were filed on March 18, 2015. The Company was assigned document number L15000048583.

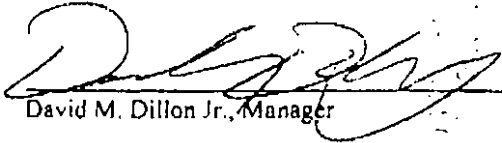
ARTICLE III – EFFECTIVE DATE
